#### **SUBJECT:**

Receive a report, hold a discussion and give staff direction regarding the proposed bond program, proposition language, voter ballot language and calling a bond election. (Staff Presenter: Martin Avila, Finance Director)

### **SUMMARY:**

On August 11, 2021 staff briefed the City Council on the proposed FY21-22 Annual Budget, the Five Year Capital Improvement Plan, and provided an overview of existing debt capacities. Following this, on August 16, 2021 staff briefed the City Council on options associated with a possible bond election. Options included: 1) the City Council placing projects directly on the ballot for voter consideration; 2) the formation of a Citizen Bond Advisory Committee to recommend projects to be placed on the ballot for voter consideration; 3) the issuance of certificate of obligation bonds for FY21-22, and consideration of a future bond election in November 2022 or May 2023. The City Council directed staff to move forward with the formation of a Bond Committee, and approved a resolution creating the Committee on September 20, 2021.

The Citizen Bond Advisory Committee consisted of fourteen members, in addition to a Committee Chair. The Committee met over a series of seven meetings between October and December 2021. Meeting topics consisted of the Committee's charge and scope, general financial information, bond ratings, possible street and infrastructure projects, a proposed police headquarters expansion, construction of fire station four, a new computer aided dispatch program, discussion on options, and formal recommendations.

The \$88,000,000 proposed bond program, funded over a 5 to 6 year period, is based on a conservative financial model with no tax increase on the debt rate which is currently \$0.1885/per \$100 value. On January 10, 2022, Bond Advisory Committee presented their recommendations to the City Council for consideration of a possible bond election, and on January 18, 2022, staff provided a report on the proposed bond program and preliminary language on the proposition and voter ballot.

City staff and Mr. Clark Kimball from McCall, Parkhurst & Horton LLP Associates, bond counsel, will be available to answer questions from Council regarding the proposed bond program, proposition language, voter ballot language and calling a bond election.

### Discussion Points

- In the January 18, 2022 Council meeting, Council posed a question regarding the impact of a failed "street proposition" would have in issuing bonds for other street projects not reflected in the proposed project list
- Pending Attorney General review allowing for police and fire projects to be included in the same proposition

### Proposed Language Proposition A

• Shall the City Council of the City of Burleson, Texas, be authorized to issue and sell bonds of said City, in the aggregate principal amount of \$33,645,000, for the public purpose of designing, constructing, improving, extending, expanding, upgrading and developing streets, roads, bridges, thoroughfares and related improvements, including utility relocation, landscaping, sidewalks and pedestrian walkways, lighting, signalization, drainage, and the purchase of any necessary land or right-of-way; with said bonds to be issued in one or more series or issues, to mature serially or otherwise not to exceed 40 years from their date and bear interest at such rate or rates, not to exceed the respective limits prescribed by law at the time of issuance, and to be sold at such price or prices as the City Council in its discretion shall determine; and shall there be levied and pledged, assessed and collected annually ad valorem taxes on all taxable property in said City in an amount sufficient, within the limits prescribed by law, to pay the annual interest on said bonds and provide a sinking fund to pay said bonds at maturity?

### Resolution

- Council approve a resolution listing the projects.
  - Contract with the voters

  - If proposition fails, City will not be able to issue COs on the projects listed for three years
    - City will be able to issue COs for other street projects not listed
  - Changes to the resolution would require Council action

### Next Step – Calling for Bond Election

- City Council must adopt an ordinance calling for a bond election not more than 90 days or less than 78 days prior to the proposed election date.
- For a May 7, 2022 bond election, City Council must adopt an ordinance calling for a bond election between February 7, 2022 and February 18, 2022

#### SUBJECT:

### **SUMMARY:**

The council provided staff direction to place on the February 7, 2022 council agenda an item ordering a Special election to be held on May 7, 2022. The Special election will have bond measures on the ballot.

At the January 18, 2022 council meeting the Council provided direction on the polling location and chose the Burleson Senior Activity Center, 216 SW Johnson Avenue. The Senior Activity Center will serve as the main early voting places as well as the election day polling location.

Council is now being asked to consider other necessary and legal requirements to be placed in the election order for the May 7, 2022 election. The required contents of the order of election are largely completed however; there is a couple of items to complete.

An election order must contain, the date of the election, the office or measures, location of main early voting place, early voting clerk's official mail address with dates for applying for ballot by mail, dates of early voting, each polling place. There is a practical method that the City of Burleson does when ordering an election. Those items are naming a Presiding and Alternate Judge, stating at least one bi-lingual clerk will be required, and the minimum number of clerks required. The city uses one precinct, Election Precinct No. 1 and it shall be established in the election order.

At this council meeting council will be asked to provide direction on early voting hours, if we are going to provide additional notice of election results, and number of minimum clerks.

### Hours of Early Voting

### Required for uniform election date:

- Must start the 12<sup>th</sup> day before the election and end the 4<sup>th</sup> day before the election
  - April 25 to May 3
- Voting 9 hours each week day
  - Between the hours of 6am and 10pm
- No weekend required
  - Can call for weekend



### Reporting Results

### Required reporting of results:

- Internet posting
  - As soon as practical must be posted on the city's website
  - Number of vote cast, votes for each measure, personal appearance election day, personal appearance early voting, mail ballots during early voting, counting and uncounted provisional ballots
- Partial results
  - Are allowed after the last voter has voted on election day
  - Must be at the entrance of the polling place
- Canvass
  - Council is canvassing authority in open meeting
  - No later than 11<sup>th</sup> day after election and no earlier than 3<sup>rd</sup> after election
  - Can only canvass when all provisional ballots are resolved and no FPC are outstanding



### Number of Clerks

### Required number of clerks:

- Presiding and Alternate Judge
  - For election day
- Number of clerks
  - Presiding Judge appoints for election day
  - Must be at least 2 besides the presiding judge
- Bi-lingual
