SUBJECT:

Consider approval of an amendment to an existing contract (CSO 2005-02-2022) with Siddons-Martin Emergency Group modifying the specification of four ambulances to diesel chassis in the amount not to exceed \$55,000. (*Staff Contact: K.T. Freeman, Fire Chief*).

SUMMARY:

At the February 21, 2022, meeting, City Council authorized the purchase of four (4) Demer 2023 Artic Range XP 153 Ford F-450 Type 1 gasoline-powered ambulances. Due to supply constraints and the manufactures limited ability to fulfill orders, Ford has been producing more diesel chassis than gasoline chassis. Siddons Martin recommends moving from gas to diesel chassis to maintain the city's desired acceptance date for the four ambulances.

Siddons Martin is anticipating having the finalized proposal to the city by the week of December 12th. In recent discussions between the vendor and staff, expected costs are estimated to be around \$55,000, including contingency for the conversion. The vendor remains committed to the city's build dates and timelines outlined in the original contract.

The action for December 12th is requesting approval of and authorizing the City Manager to execute the contract amendment in the amount not to exceed \$55,000.

Staff feels the move is necessary to keep the proposed timeline.

Staff will continue to work with the vendor and provide council updates as requested.

Proposal Amendment
