1. Approve the December 9, 2021 meeting minutes.

A motion was made by Michael Massey and seconded by Thomas Fleeger to accept the minutes as presented. The motion passed 4-0, with Matthew Quinn, Emily Quinn and Jessie Farris being absent.

2. Citizen Appearances

None

3. Receive a report, hold a discussion and provide staff feedback regarding potential improvements to Claudia's Playground. (Staff presenter: Jen Basham, Director)

Claudia's Playground has been identified as a priority for development through the parks master plan. \$400,000 has been identified in the capital improvement plan to develop the park. The site is situated in a residential area. An initial review of the park has determined that based on the size and location of the park, Claudia's Playground is considered a neighborhood park. Typical amenities for a neighborhood park (a park that is between 1-15 acres) include: play feature, benches, picnic table, parking, lighting and drinking fountain. Claudia's Playground is 3.27 acres and has existing parking on site. Future improvements could include parking expansion, additional lighting, and a restroom. 2 surveys were sent out to the community to get feedback on specific elements and final design options. 641 respondents provided feedback on the concepts submitted. 5 design firms created concepts for the park including: BCI Burke, LSI, Berliner, Miracle, and Kraftsman. Miracle's conceptual design was the overall supported winner with 48% of votes. Sherry Scott made a motion to recommend Miracle's concept as supported by the survey. Thomas Fleeger seconded the

motion. The motion passed 4-0 with Matthew Quinn, Emily Quinn and Jessie Farris being absent.

4. Receive a report, hold a discussion, and provide staff feedback regarding potential improvements to Cindy Park. (Staff Presenter: Jen Basham, Parks and Recreation Director)

Cindy Park has been identified as a priority for development through the parks master plan. \$200,000 has been identified in the capital improvement plan to develop the park. The site is situated in a residential area. An initial review of the park has determined that based on the size and location of the park, Cindy Park is considered a pocket park. Typical amenities for a pocket park (a park that is less than .5 acres) include: play feature, benches, picnic table, and drinking fountain. They do not include parking, restrooms, lighting, or paved trails (unless connecting to a linear linkage). 2 surveys were sent out to the community to get feedback on specific elements and final design options. 579 respondents provided feedback on the concepts submitted. 5 design firms created concepts for the park including: BCI Burke, LSI, Berliner, Miracle, and Kraftsman. Kraftsman's conceptual design was the overall supported winner with 54% of the votes. Thomas Fleeger made a motion to recommend Kraftman's concept as supported in the survey. Sherry Scott seconded the motion. The motion passed 4-0, with Matthew Quinn, Emily, Quinn and Jessie Farris being absent.

5. Receive a report regarding Parks and Recreation program and updates. (Staff presenter: Jen Basham, Director)

The board was briefed in regards to special events, programming, revenue and capital improvement projects for The BRiCk, Golf, Russell Farms, and Parks. A discussion followed.

SUMMARY:

The Burleson Chamber of Commerce has hosted Honey Tour for over 20 years in the community. In 2020 and 2021 the race had to be canceled due to COVID. The Chamber would like to bring the event back in 2023 with an enhanced experience. The event has traditionally held a bike race ranging between 7-67 miles throughout multiple communities starting from Centennial High School. The last year the event was held it grossed \$48,599 in revenue.

For 2023 the Chamber would like to partner with the city to create a signature community events. The added components being proposed include:

- Carnival
- Food Trucks
- Live Entertainment

Vendors

The projected cost of the event for the enhancements are \$23,160 with approximately \$20,000 projected to be covered by sponsorships, carnival revenue, and food and vendor spaces.

If approved the Parks and Recreation Department will budget for the event in the FY 23 budget process.



SUMMARY:

The City of Burleson approved a policy in 2009 to determine the method for naming public spaces and facilities within the city. The policy creates a method for formal, fair and consistent naming. Guidelines for selecting the name of a city owned property include the following areas:

- Predominant natural features
- Adjoining streets or subdivisions
- Historic or heroic events
- Outstanding individuals
- Public officials
- Benefactors or donors

The approval process for selecting the name of a space is determined based off of who is initiating the request. If the city initiates the requests, the City Manager's office will present a list of potential names to the City Council for approval. If it is the initial naming of the space or facility; naming should occur prior to construction completion. The city or public can request that an existing space be renamed using the same process. If the public would like to request a name they must submit the request in writing to the City Manager.

City staff requested that the naming of the new dog park be placed out to the community for a public vote at the January 3, 2022 City Council meeting. A list of prospective names was placed in a poll for the community to respond to from January 7- January 21, 2022.

Burleson Bark Park won with 233 of the 359 votes cast.
